Overview

This release is a maintenance release of the VAT Reporting application for the month of April 19. It includes changes in reporting documents, modifications in VAT Reporting and bug fixes.

Spanish Cash Accounting - Modelo 303

We have implemented new combinations so that the user can report transactions to the boxes corresponding to the cash accounting regime. The new combinations (with start date 1 January 2019), are listed below:

When a document under one of these generic codes, transactions IDs, or any other transaction ID using one of these combinations, is uploaded to VAT Reporting, it will be put on hold and reported in the cash accounting boxes 62, 63, 74, 75 of the VAT Return corresponding to the transaction date period. Once the document is cleared, the operation will be reported in the normal boxes of the return corresponding to the clearance period.

For the cash accounting functionality to behave as discussed in the previous paragraph when using transaction IDs, the option "Clearing date" should be chosen in the field "Reporting date" in the Wizard when setting up the VAT code. This is not necessary in case of generic codes; for these "Clearing date" will be applied by default.

The mappings for the Annual Return Modelo 390 and Annual Return section of Modelo 303 will be wholly reviewed in next releases. The cash accounting regime functionality for the Annual Return Modelo 390 and Modelo 347 will be also reviewed separately in coming releases.

VR-5825	VAT Code Simulator - We have reverted changes implemented in VR - 4995 (19.3 release), as this change was implemented in error.
VR-5816	LT - VAT Book - We have fixed a bug that prevented the correct display of the VAT Book in VAT Reporting.
VR-5802	IFA - Comments & Attachments - We have added logging when a user adds, alters and deletes comments or attachments to an invoice. These can be found in Data > Changes Log.
VR-5801	MTD Agents – The Making Tax Digital for Agents manual has been added to VAT Reporting, this can be found in Help>Manuals
VR-5767	GL Reconciliations - The GL reconciliation status overview report (VR side) currently errors if there is a duplicate value in one of the settings. The ability to duplicate a value has been fixed in a previous version, however if a duplicate value already exists, it will currently fail. This issue has now been resolved and the report will no longer produce an error in this scenario.
VR-5764	CZ - VAT Book - We have improved the functionality in Reporting Check regarding the out of scope tax codes. Previously the Reporting Check was giving errors due to missing supplier invoice numbers, for out of scope tax codes. This error has now been fixed.
VR-5763	MTD – We have added better error messaging when 'not found' responses are returned from the HMRC. We are in the process of providing more meaningful messages for all errors returned from HMRC, in VAT Reporting, for MTD. This is a work in progress and further improvements will be made in future releases.

VR-5752	PL - Intrastat - e-file - We have reviewed the file to make sure that UZ (Uzbekistan) is allowed by Reporting Check and is reported in the field Country of Origin of the XML file, in accordance to the last guidelines in force.
VR-5743	MTD – We have made changes to prevent a GB customer who is active for MTD being able to reopen their MTD submitted returns. All countries (including GB) who are not active for MTD will still be able to re-open their submitted returns as normal.
VR-5742	LV - Intrastat - 2019 - e-file - We have added new version of the intrastat XML in LV for 2019. The only change consists in the removal of the node AuthorizedInfo from the XML file.
VR-5726	ES - Modelo 353 (Group Return) - Following a database change in v19.1.1, the modelo 353 would error when saved. In this release we have rectified this issue and the report can now be saved again.
VR-5715	IT- Quarterly Modello IVA TR - PDF - 2019 - We have added the new Modello IVA TR corresponding to operations carried out in 2019.
VR-5712	Generic Codes - When GBSO000C was used, Reporting Check erroneously asked the supplier to register in GB. We have now fixed this error.
VR-5689	DK - Intrastat - The threshold for declaring arrivals have been updated to the values of 3.000.000,00 EUR for the Standard reporting and 250.000,00 EUR for the Simplified reporting in 2019.For dispatches the threshold have also been updated to the value of 6.000.000,00 EUR for the Standard reporting and 150.00,00 EUR for the Simplified reporting in 2019.
VR-5688	PL - Intrastat - The thresholds for declaring arrivals have been updated to the values of 65.000.000,00 PLN for the Standard reporting and 4.000.00,00 PLN for the Simplified reporting in 2019. For dispatches the thresholds have also been updated to the value of 108.000.000,00 PLN for the Standard reporting and 2.000.000,00 PLN for the Simplified reporting in 2019.
VR-5678	NL - Intrastat - e-file - 2019 - We now allow code 9 (other transactions) in field ID Types of the Intrastat report, in accordance with the guidelines in force. This applies to both Arrivals and Dispatches files.
VR-5670	Data Mining – Invoice Lines – We have added the field OwnReference the Data Mining > Invoice lines report. It can now be populated with customer specific data. For a customer to be able to import this data, the column - OwnReference, needs to be populated in the Invoice Template. The data added into this column will then be imported into VAT Reporting and will be viewable in the Data Mining > Invoice lines report.
VR-5654	HR - Intrastat - The threshold for declaring arrivals have been updated to the new value of 2.200.000,00 HRK in 2019. For dispatches the threshold has also been updated to the new value of 1.200.000,00 HRK in 2019.

VR-5650	VAT Return History - We have made some changes to better identify when a period for a region has been closed automatically due to the main country being closed. Previously, at a database level, the reason for the box closing was cut off due to text length.
VR-5646	DK - Intrastat - The threshold for declaring arrivals have been updated to the new value of 6.700.000,00 DKK in 2019. For dispatches the threshold has also been updated to the new value of 5.000.000,00 DKK in 2019.
VR-5626	Data Mining Invoice Lines - We have fixed an issue where it was possible, when drilling down on a row in the data mining report, for a different invoice to be displayed in the invoice flow analyser.
VR-5622	AT - Intrastat - e-file - 2019 - We have added the new Intrastat e-file corresponding to 2019.
VR-5620	EE - Intrastat - We have fixed an issue by which the secondary unit "1 000 kWh" triggered an error when uploaded to Reporting Check. In addition, we have also ensured that the 3-digit codes, that apply to EE, are correctly reported in the Arrivals and Dispatches e-file.
VR-5607	FR - EC Listing Form CERFA -13964 - PDF - 2019 - We have added the new EC Listing form for 2019 (both FR and EN versions).
VR-5606	 DE - We have updated the mappings for transaction ID 992 (ID993 for CN) Supply - intra_community_supply - flat_rate - farmer (combination ID 20 and 60). This is now reported in Z29 for the Monthly return (Tax base only) and on Z48 of the Annual return 2018. In addition, we have created the following combination ID's so clients can use them to report in other boxes: Combination ID 21 and 61 - local flat rate farmer scheme Monthly Z30 TB and VAT amount Annual Z49 TB and VAT amount In all cases, the start date is 1 January 2018. A re set up and re delivery of the code is necessary.
VR-5603	IT - Annual VAT Return - PDF - 2019 - We have now added the English translation for the Annual VAT Return 2019 corresponding to operations made during fiscal year 2018.
VR-5591	GR - Mappings - Transaction ID 694 (Triangulation - middleman part B) is now mapped to the following boxes: taxable base, 342 and 312 from 1 September 2015.A re set up the VAT codes and a re-delivery is necessary.

VR-5583	In 18.11.1 we made a change to functionality that allowed you to add a file attachment to a document (reference: VR-5012). In that version we implemented the ability to add a description to an attachment (as part of the generic template when using the columns "ScannedDocumentFileName" and "ScannedDocumentFileDescription"). This change broke some functionality available in Invoice Flow Analyzer, which has now been fixed.
VR-5570	RCCL - We have fixed an issue which caused RCCL to run out of memory when processing large amounts of data (~70,000 documents in one extract file), in one run.
VR-5562	Database - We have fixed an issue where we were not storing special characters correctly in the database, which was then displaying them incorrectly in produced reports. This issue has now been fixed and special characters are now stored and presented in reports correctly.
VR-5559	LT - Intrastat - e-file - RegionDispatch is now a mandatory field in the Dispatches file when the Country Origin is LT. We have implemented this change in our e-file accordingly. Values accepted in this field are those corresponding to the 10 different regions of the country.
VR-5514	ES - Cash accounting - Modelo 303 and 390 - We have implemented new combinations so that the user can report transactions to the boxes corresponding to the cash accounting regime. The new combinations (with start date 1 January 2019), are in the overview section found at the start of this document.
VR-5457	SI - Reverse Charge listing (PD-O) - PDF - 2019 - We have now added the Hungarian translation of the PD-O corresponding to 2019.
VR-5456	SI - Reverse Charge listing (PD-O) - PDF - 2019 - We have now added the English translation of the PD-O corresponding to 2019.
VR-5378	PL - VAT Book - We have updated Reporting Check so that when the other party's address is not present an error is reported. Address is a mandatory field and, therefore, cannot be left empty.
VR-5364	ES - Intrastat Return for Sales - We do not currently split the Intrastat Return for Sales for AEAT. In Spain this file should contain a maximum of 999 records. We have therefore implemented a change that splits the file and will now create a new separate file every 999 records. The original single file, showing all records prior to the split, will continue to be produced.
VR-5360	CZ - Intrastat - Now values "UN" and "EU" trigger an error in Reporting Check if present in Country of Origin field. In addition, we now allow codes "QU", "QV", "QR", "QW", "QP". These changes and additions are in line with the current guidelines in force.
VR-5323	ESGC - Modelo 417 - PDF - 2019 - We have now added the English translation for the Form corresponding to 2019.

VR-5269	Proxy Server - In the application menu Settings > General Settings > Proxy Settings, we have added a new field to the Proxy tab to allow you to set the Windows Domain which can be required. We have also improved the logic around authentication to a proxy server when using the SII submission tool; previously it was not correctly using the Proxy Password, as the password is stored encoded in the database, The submission tool has been updated to decode the password to allow it to send the password via a Proxy Server. We have also added additional logging in the Data Mining > ES SII > Logs to help troubleshoot proxy authentication issues.
VR-5174	LT - VAT Book - We have improved the functionality for missing reference invoice number and missing reference invoice date, for credit notes. Both references are required in the LT VAT Book. Previously, Reporting Check passed credit note documents without this information, now Reporting Check will ask for it if it is not present.
VR-5171	PL - JPK_FA - We have improved this report. When invoices are issued in different currencies (document currency), they will now be split into one XML file per document currency used. Each of these split files will need to be uploaded to the Tax Administration when requested.
VR-4309	RO - EC Listing - PDF- 2019 - We have added the RO EC Listing corresponding to 2019.
VR-3038	The client and supplier annex, part of the PT VAT Return is now supported in VAT Reporting. The logic implemented in the listings is as follows: Suppliers': Amounts reported in boxes 20, 21, 22, 23, 24 are reported into the supplier's listing, nothing else. In case of reverse charge, the reporter s VAT number is the one to be reported (not the supplier's). Clients': Amounts reported in boxes 8 of the return flow to the client's listing.
VR-734	PL - SAFT - We have added the JPK_FA report to VAT Reporting. This can be found on the VAT Book tab under frequency Yearly. Mayor changes will come into force in July 2019. The file will be reviewed and updated before July release.
VR-491	RO - Sales and Purchases Ledgers - We have reviewed and updated the Romanian translation of the ledgers.

This section provides details on how to update to the latest version. For the purposes of this documentation, we assume that you have an existing installation and you have the necessary access privilege to perform the upgrade.

Download

Database Back Up

Close all running VAT Reporting windows and take a full backup of the SQL Database. This can be done in the **SQL Server Management Studio**, from the database right-click menu **Tasks > Back Up.**

Stop Inbox Monitor & SII Processor Scheduled Task

Before installing the update of VAT Reporting stop the Inbox Monitoring Service and check there are no RCCL.exe processes still running, and stop the Windows Scheduled Task if you are using SII.

Install

Run the installer exe, once it completes open VAT Reporting and wait while it automatically handles any database upgrade.

Start Inbox Monitor

Start the Windows service, and then in VAT Reporting use the File > Send test file... and confirm the inbox is up and processing.

Start SII Processor Scheduled Task

Re-enable the Windows Scheduled Task (if you are using SII).

VAT Reporting is now ready for use!
