#### Overview

This release is a patch to our 20.10.1 maintenance release of the VAT Reporting application.

### Change Log

| VR-10768 | PL – JPK-VAT - resolved an issue where special characters were not escaped correctly in the saved XML.   |
| VR-10765 | PL - JPK-VAT - resolved an issue where refund boxes were populated for a NIL return.   |
| VR-10753 | PL - JPK-VAT - We improved the report so that country code GR for Greece is now replaced with country code EL.   |
| VR-10736 | PL - JP-VAT - We have made some improvements and corrections on the JPK-VAT. We now always populate the field 'NrDostawcy' in the JPK-VAT with "brak" (empty) when no VAT Number or Tax Number was found for the trading partner.<br>For bad debt relief scenarios when the field ItemIdentifier contains the value BDR we will set the field KorektaPodstawyOpodt to 1 in the ledger.<br>The user will still need to calculate the correct amounts to put in the fields P_68, P_69.   |
| VR-10720 | GB - EC Listing - Fixed Format/CSV - We resolved a bug where the amounts on the CSV report were showing with decimals. This is now fixed to show as rounded down to the nearest pound.   |
| VR-10653 | PL - JPK-VAT - We resolved the issue where quarterly returns would populate the whole return with a declaration for each month. This is now fixed so that the first two months will include only the Sales & Purchase invoice details (so called ledgers) and the last month of the quarter will show the invoice details of corresponding to the last month and the declaration for the whole quarter.<br>In order for this to work correctly, the user must set up the VAT Return and VAT Book as Quarterly filings in the settings, and use the "Use your own dates" -filter to define the period.<br>The end date should match the end date for the invoice scope in the ledger.<br>Example for Q4 period:<br>October: user can select the month October from the drop down menu or use filter "Use your own dates" and set it 01/10 till 31/10<br>November: user can select the month November from the drop down menu or use filter "Use your own dates" and set it 01/10 till 31/11 or 01/11 till 31/11.<br>December: user needs to select the whole quarter on the filter "Use your own dates" to 01/10 till 31/12 for the VAT return section (Deklaracja) to be included in the file. |

This section provides details on how to update to the latest version. For the purposes of this documentation, we assume that you have an existing installation and you have the necessary access privilege to perform the upgrade.

#### Download

#### Database Back Up

Close all running VAT Reporting windows and take a full backup of the SQL Database. This can be done in the **SQL Server Management Studio**, from the database right-click menu **Tasks > Back Up.** 

#### Stop Inbox Monitor & SII Processor Scheduled Task

Before installing the update of VAT Reporting stop the Inbox Monitoring Service and check there are no RCCL.exe processes still running and stop the Windows Scheduled Task if you are using SII.

#### Install

Run the installer exe, once it completes open VAT Reporting and wait while it automatically handles any database upgrade.

#### **Start Inbox Monitor**

Start the Windows service, and then in VAT Reporting use the File > Send test file... and confirm the inbox is up and processing.

#### **Start SII Processor Scheduled Task**

Re-enable the Windows Scheduled Task (if you are using SII).

#### VAT Reporting is now ready for use!
